Instructions for Completing Recreational Vessel Pass Application

NOTE: If accessing this Application online, you must print and submit as instructed below. E-mail submissions cannot be accepted.

To be eligible for a Seasonal, Ten-Day or Two-Day Pass, the vessel **must be motorized and registered as a recreational vessel** by the appropriate state, provincial or national agency.

- Section I: Applicant Information Applicant provides contact and vessel information.
- Section II: Recreational Pass Type

Applicant uses the information below to determine which of the three types of Passes offered is appropriate. Once the Pass type is determined, the applicant checks the box that corresponds with the size of the vessel.

<u>Seasonal Passes</u> are designed for boaters who frequently use the Canal System. Seasonal Passes are issued to a specific vessel for use by that vessel only and are valid for the **entire current navigational season**. Lockages are unlimited for the duration of the current navigational season.

<u>Ten-Day Passes</u> are designed for boaters who plan to take an excursion across the Canal System. Ten-Day Passes are issued to a specific vessel for use by that vessel only and are valid for **the day it is presented and the next nine calendar days** at locks/lift bridges during the current navigational season. Lockages are unlimited during the ten days of use.

<u>Two-Day Passes</u> are designed for boaters who plan to use the Canal System occasionally. Two-Day Passes are issued to a specific vessel for use by that vessel only and are valid for **any two consecutive days** at locks/lift bridges during the current navigational season. Lockages are unlimited during the two days of use.

• Section III: Vessel Owner/Operator Certification

By signing in Section III, the Applicant certifies that the information provided on this Application is accurate and true and will comply with all rules pertaining to usage of the Canal System. Rules regarding use of Seasonal, Ten-Day and Two-Day Passes are available in the publication entitled RECREATIONAL PASS INFORMATION (TAP-921). This publication is available at *www.nyscanals.gov* or may be obtained from any sales location.

Section IV: Credit Card Information
